The recent release of the National Waste Policy Action Plan highlights the need for all levels of government to increase their procurement of recycled materials. As such, this workshop aims to facilitate the development of a collective commitment/action, for councils in attendance, that will lead to an increase in the procurement of recycled content in the region.

The workshop will guide participants to explore:

- what current procurement of recycled content looks like in the region
- what barriers are preventing procurement of recycled content
- what existing availability/opportunities there are

and then to investigate:

- ways to overcome barriers and realise opportunities
- the potential of developing and committing to a target (or targets)
- potential project ideas
